**A RESOLUTION AUTHORIZING THE CITY OF DUNES CITY TO APPLY FOR THE 2021 OREGON COMMUNITY PATHS GRANT FROM THE OREGON DEPARTMENT OF TRANSPORTATION FOR THE DESIGN AND DEVELOPMENT OF A HIKING AND BIKING TRAIL (REBECCA’S TRAIL) AND DELEGATING AUTHORITY TO THE CITY ADMINISTRATOR TO SIGN THE GRANT APPLICATION.**

**WHEREAS**, the Oregon Department of Transportation is accepting applications for the 2021 Oregon Community Paths Grant Program; and

**WHEREAS**, the Dunes City Council desires to participate in this grant program to the greatest extent possible as a means of development, construction, reconstruction, major resurfacing, and other improvements of multiuse paths that improve access and safety for people walking and bicycling; and

**WHEREAS**, in February of 2020, Dunes City purchased certain properties bearing Map and Tax Lot Numbers 19-12-27-40-02000, 19-12-27-40-02001 and 19-12-27-40-02300 for purposes of designing and developing a hiking and biking trail that connects the North Beach area with the Westlake area of Dunes City; and

**WHEREAS**, the design, development and installation of a paved ADA compliant recreational hiking and biking trail on these properties that joins the North side of Dunes City with the South side of Dunes City will provide recreational opportunities where none previously existed, will provide an emergency evacuation path for areas identified by the Department of Geology and Mineral Industries (DOGAMI) to be within the tsunami inundation zone, and will preserve those lands located below the 100-year flood line from future development.


**NOW, THEREFORE, BE IT RESOLVED BY THE DUNES CITY COUNCIL AS FOLLOWS:**

The City Council of Dunes City demonstrates its support for the submittal of a grant application to the Oregon Department of Transportation for the design, development and installation of a paved hiking and biking trail across properties located and in and owned by Dunes City and bearing Map and Tax Lot Numbers 19-12-27-40-02000, 19-12-27-40-02001 and 19-12-27-40-02300, thus creating Rebecca’s Trail;


This Resolution shall be effective following its adoption by the City Council of the City of Dunes City.
