A RESOLUTION AUTHORIZING THE CITY OF DUNES CITY TO APPLY FOR A LOCAL GOVERNMENT GRANT FROM THE OREGON PARKS AND RECREATION DEPARTMENT FOR THE DEVELOPMENT OF A HIKING AND BIKING TRAIL AT REBECCA'S TRAIL PARK AND DELEGATING AUTHORITY TO THE CITY ADMINISTRATOR TO SIGN THE GRANT APPLICATION.

WHEREAS, the Oregon Parks and Recreation Department is accepting applications for the 2021 Oregon Community Paths Grant Program; and

WHEREAS, the Dunes City Council desires to participate in this grant program to the greatest extent possible as a means of providing needed park and recreations acquisitions, improvements and enhancements; and

WHEREAS, the Dunes City Council has identified improvements at Rebecca's Trail as a high priority need in the City of Dunes City; and

WHEREAS, the City seeks professional engineering and design services, project needs identification, contracted construction services, and possible acquisition of property, if necessary, to complete the initial installation of the proposed ADA compliant hiking and biking trail that connects the North Beach area with the Westlake area of Dunes City; and

WHEREAS, the design, development and installation of a paved ADA compliant recreational hiking and biking trail on these properties that joins the North side of Dunes City with the South side of Dunes City will provide recreational opportunities where none previously existed, will provide an emergency evacuation path for areas identified by the Department of Geology and Mineral Industries (DOGAMI) to be within the tsunami inundation zone, and will preserve those lands located below the 100-year flood line from future development.

WHEREAS, Dunes City has available local matching funds to fulfill its share of obligation related to this grant application should the grant funds be awarded; and

WHEREAS, Dunes City will provide adequate funding for on-going operations and maintenance of this park and recreation facility should the grant funds be awarded.

NOW, THEREFORE, BE IT RESOLVED BY THE DUNES CITY COUNCIL AS FOLLOWS:

Section 1: The City Council of Dunes City demonstrates its support for the submittal of a grant application to the Oregon Parks and Recreation Department for the Department of Transportation for professional engineering and design services, project need identification, and contracted construction services and acquisition of property, if necessary, to complete the initial installation of a paved hiking and biking trail across properties located in and owned by Dunes City, thus creating Rebecca's Trail;

This Resolution shall be effective following its adoption by the City Council of the City of Dunes City.
