Citizen Geneva Jackson stated that Councilor Joe Giammona had voted twice not to approve the current budget as is written and that Council should consider that before approving the budget. Citizen Jeanne Jackson read her letter presented to the Council members.

Council President Susan Snow stated that she was still working with the state and it is still in process.

D. Road Report

Acting City Administrator Lila Timmons stated that a complaint had been received by City Hall in regards to potholes on Cloud Nine.

E. Permit Report

Council President Susan Snow stated the current Permit Report was on the dais in front of the Councilors.

#### 9. NEW BUSINESS

A. Resolution Series 2024, No. 4 regarding the City's election and qualifications to receive State gas taxes and liquor taxes pursuant to ORS 221.760.

Council President Susan Snow asked if the Council desired to discuss. Councilor Melissa Stinson asked how the City ensures the follow through on the roads with taxes received. Council President Susan Snow stated that this resolution dealt with receiving of the taxes. Councilor Melissa Stinson stated that she wanted to make sure that there is sufficient follow up to ensure the funds are being used appropriately. Council President Susan Snow asked if there was a motion to accept the resolution. Councilor Melissa Stinson asked if the signature line on the document needed to be changed. Acting City Administrator Lila Timmons stated that the signature line has been changed. Councilor Melissa Stinson made a motion to approve the Resolution Series 2024, No. 4. Councilor Rich Olson seconded the motion. The motion passed unanimously.

- B. Resolution Series 2024, No. 5, regarding authorizing City Administrator Jamie Mills to sign the audit documents.
  - Councilor Joe Giammona asked which audit the City Administrator Jamie Mills is authorized to sign. Acting City Administrator Lila Timmons stated that she asked for the latest audit draft from the audit company. Councilor Joe Giammona stated that there were sizable differences between the two drafts in his possession. Acting City Administrator Lila Timmons stated that the audit has been signed. Councilor Melissa Stinson made a motion to disapprove of the signing of the audit documents. Councilor Joe Giammona seconded the motion. The motion to disapprove of the signing the audit documents passed unanimously.
- C. Consideration on Fiscal Y 2024-2025 budget as approved by the Budget Committee following public hearing on May 7, 2024.

Councilor Chris Clemons made a motion to approve the budget with the expectation that the budget will be modified. Councilor Joe Giammona asked what modifying the budget meant. Council President Susan Snow answered that it will need to be amended. Councilor Joe Giammona asked about the process to amend the budget. Councilor Chris Clemons stated that he felt the amendments to the budget would be more of a refinement as the Councilors understand more of the budget process. Council President Susan Snow stated that the budget can be amended for any reason. Council President Susan Snow further stated that she wanted to provide the Councilors with as much information as needed. Council President Susan Snow stated that there was no second so the motion died. Councilor Joe Giammona asked if they are attempting to get a motion made to put the budget up for the public hearing. Council President Susan Snow stated that the

hearing would still take place since the hearing has been posted. Councilor Joe Giammona stated that the audit numbers are the beginning balance and the Council is still unsure as to which audit is the final draft. Council President Susan Snow stated that any new numbers would require a new posting and public hearing requirement.

D. Consideration of Ordinance No. 269, declaring a Temporary halt on the issuance of Short-Term rental permits and other matters relating thereto Council President Susan Snow read from the script. Councilor Melissa Stinson made a motion to read the Ordinance No. 269 by title only. Councilor Chris Clemons seconded the motion.

## 1. First Reading

Council President Susan Snow asked if any Councilors had a potential conflict of interest. There were none.

Council President Susan Snow opened the meeting for public comment at 6:40 pm in regards to Ordinance No. 269.

Council President Susan Snow asked if anyone in the audience would like to comment in support of Ordinance No. 269. There were no comment.

Council President Susan Snow asked if anyone in the audience would like to comment in opposition of Ordinance No. 269. There were no comments.

Council President Susan Snow closed the meeting for public comment at 6:42 pm.

## 2. Second Reading

Councilor Rich Olson made a motion to read Ordinance No. 269 by title only Councilor Chris Clemons seconded the motion.

## 3. Deliberation

Council President Susan Snow asked Councilors if any of them had any questions or comments. Councilor Joe Giammona asked why only 60 days? Council President Susan Snow stated that the 60 days starts from July 1<sup>st</sup>. Acting City Administrator Lila Timmons read the line in Ordinance No. 269 that states 60 days starts from July 1<sup>st</sup>. Council President Susan Snow asked if there was a motion to approve the Ordinance No. 269 as presented. Councilor Melissa Stinson made a motion to approve the Ordinance No. 269 as presented. Councilor Chris Clemons seconded the motion. The motion passed unanimously.

E. Review proposal to increase the limit of crime coverage for insurance.

The Councilors discussed the amounts of coverage on each line item and felt that the
Council needed the items more clearly defined and adjusted. Acting City Administrator
Lila Timmons stated that she would set up a meeting with Zolezzi Insurance to get more
information. Councilor Rich Olson made a motion to get corrections made to the
insurance proposal. Councilor Joe Giammona seconded the motion. The motion passed
unanimously.

## F. Proposal for new janitorial service

Council President Susan Snow stated that this proposal is for janitorial services that are not currently getting done. Councilor Melissa Stinson expressed concern due to conflicting terms. Councilor Chris Clemons suggested that the Council put maximum time limit for the first and subsequent visits. Council President Susan Snow asked the Acting City Administrator Lila Timmons to find out what chemicals were being used to prevent allergies with City staff. Councilor Joe Giammona made a motion to accept the proposal for janitorial services with a maximum 4 hours on the first visit and 3 hours on subsequent cleans. Councilor Chris Clemons seconded the motion. The motion passed unanimously.

# G. Dunes City Roadway Classifications

Council President Susan Snow asked for more details about classifications. Acting City Administrator Lila Timmons stated that there was an e-mail received from ODOT asking Dunes City if they need to update any road classifications. Councilor Chris Clemons made a motion to except the Roadway Classifications. Councilor Rich Olson seconded the motion. The motion passed unanimously.

## H. Pre-application Hazard Mitigation Grant Program

Council President Susan Snow asked Acting City Administrator Lila Timmons for more information. Acting City Administrator Lila Timmons stated that there are certain projects that Dunes City already had approved through FEMA and this grant would provide money for one of those projects. It is a 75/25 match. Council President Susan Snow said that it would be good to have a Town Hall and asked Westlake citizens what they would want in case of an emergency. Councilor Joe Giammona made a motion to approve the pre-application for the Hazard Mitigation Grant Program. Councilor Chris Clemons seconded the motion. The motion passed unanimously.

I. Grant Acting City Administrator Lila Timmons permission to be put on bank account and open new credit card. Umpqua Bank to take off all previous signors to bank account and add Acting City Administrator Lila Timmons, Mayor Ed McGuire and Council President Susan Snow. Councilor Chris Clemons made a motion to put Acting City Administrator Lila Timmons on all bank accounts and to open a new credit card. Councilor Melissa Stinson seconded the motion. The motion passed unanimously.

#### A. Hearing proposed Fiscal Year 2024-2025 Budget.

Council President Susan Snow read from script. Council President Susan Snow opened the meeting for public hearing at 7:33 pm. Council President Susan Snow asked if anyone in the audience wanted to comment. Council President Susan Snow recognized Alex Beloin. Mr. Beloin read a letter to the Council. Council President Susan Snow recognized Geneva Jackson. Ms. Jackson stated she had submitted a letter to the Council encouraging the Councilors to submit a correct budget to the state. Council President Susan Snow asked if there were other comments. There were none. Council President Susan Snow closed the public hearing at 7:39 pm.
