RESOLUTION SERIES 2021, NO. 2 (06-23-2021)

**A RESOLUTION CERTIFYING DUNES CITY PROVIDES FOUR
MUNICIPAL SERVICES ENUMERATED IN SECTION 1, ORS 221.760; AND
DECLARING THE CITY'S ELECTION TO RECEIVE STATE REVENUES.**

WHEREAS, ORS 221.760 provides as follows:

Section 1. The officer responsible for disbursing funds to cities under ORS 323.455, 366.785 to 366.820 and 471.805 shall, in the case of a city located within a county having more than 100,000 inhabitants according to the most recent Federal decennial census, disburse such funds only if the city provides four or more of the following services:

- (1) Police protection; (2) Fire protection; (3) Street construction, maintenance, and lighting; (4) Sanitary sewer; (5) Storm sewers; (6) Planning, zoning, and subdivision control; (7) One or more utility services.

and

WHEREAS, City Officials recognize the desirability of assisting the State Officer responsible for determining the eligibility of cities to receive such funds in accordance with ORS 221.760.

NOW, THEREFORE, BE IT RESOLVED that the City of Dunes City hereby certifies that it provides the following five municipal services enumerated in Section 1, ORS 221.760:

- (1) Enhanced Fire protection through Agreement;
- (2) Street construction, maintenance, & lighting;
- (3) Storm sewers;
- (4) Planning, zoning, and subdivision control; and
- (5) A water utility service.

BE IT FURTHER RESOLVED that the City of Dunes City hereby elects to receive state revenues for fiscal year 2021-2022.




